Deposits to hold a puppy are non-refundable, but may be applied to a future litter for up to 12 months. Please refer to the Deposit Form for additional information.

Payment must be in the form of cash, postal money order, or we can accept your credit card payment through Paypal. (If using Paypal, please add an additional 3.5%. Please note: No chargebacks will be honored or issued through Paypal for any reason.) No personal checks can be accepted.

Puppies MAY be shipped after 8 weeks of age, but it is at the seller's discretion not to ship until the puppy is appropriately healthy, strong, and at least 2 pounds.

**Cherished Shih Tzu** guarantees the puppy to be healthy at the time of purchase, and current on all vaccinations and wormings. In addition, Cherished Shih Tzu also guarantees puppy to be free from genetic defects that **are detrimental to the puppy's health** for two (2) years from the puppy's date of birth.

In the event that a genetic defect is found by a licensed Veterinarian within the warranty period, **Cherished Shih Tzu** will replace the puppy with another puppy of equal value

upon receipt of a letter confirming diagnosis by a licensed Veterinarian, and the return of the original puppy. ***Cherished Shih Tzu*** cannot predict a time frame when a replacement puppy will be made available, but buyer will have first pick from subsequent litters.

***Cherished Shih Tzu*** guarantees puppy for 10 days from the date of sale against the following diseases: Parvovirus, Distemper, Leptospirosis, Hepatitis, Parainfluenza, and Corona Virus.

In the event that any of the above-stated diseases are diagnosed within the 10-day period, the seller is to be notified within 24 hours. Two licensed veterinarians verifying the diagnosis with lab results must be provided within 3 business days after said diagnosis. Once we have received confirmation of the submitted diagnosis, we will accept the immediate return of the puppy and refund the purchase price.

***Cherished Shih Tzu*** will assume no shipping costs associated with sale or warranty.

Hernias are very common in Shih Tzus. ***Cherished Shih Tzu*** will reimburse monies needed for surgical repair, up to \$200.00, **only if the hernia is life-threatening, and is certified by a letter from a Veterinarian.** Letter of diagnosis may be confirmed by seller's own Veterinarian.

Buyer must have puppy examined by a licensed Veterinarian by the time the next vaccine due date or all warranties are void. Next vaccines are due\_\_\_\_\_.

Warranty does not cover any diseases for which vaccinations could prevent, except within the 10 day from date of sale period.

Buyer will incur all charges for future vaccinations, wormings, and initial office exam within the three-day period.

All warranties are void in the event that buyer neglects to have puppy properly vaccinated by a licensed Veterinarian, or in any way harms, neglects, or fails to give puppy proper medical attention.

While no refunds will be given, ***Cherished Shih Tzu*** is willing to take back the puppy at any time if the buyer is unable to keep due to any circumstances.

Puppy is sold as a pet, and while it may be of breeding or show quality, it is the buyer's sole discretion to do so.

No guarantee is made in regards to size or color. Any estimates given are based solely on the breeder's experience.

No other guarantee is made or implied, except as stated in this written guarantee.

Warranty applies to the original buyer only, and is not transferable.

By signing below, both parties acknowledge that they have read and understand the above contract/warranty, and agree to the terms therein. Both seller and buyer will receive, and should maintain, a copy of this contract.
